3. The admission will be provisional and subject to the production of following testimonials/ documents:

 - Date of Birth Certificate
 - Provisional and Character Certificate from the institution last attended (in original only)
 - Marks card of Graduation
 - Category Certificate (If applicable) issued by competent authority.
 - CUET Entrance Score
 - Migration Certificate (if applicable)
4. The candidates need to deposit the above-mentioned testimonials/ certificates in original and two attested photocopies of each testimonial/certificate

5. The window of admission for Merit list No. 4 will remain open from 04th October 2023 to 6th October 2023.
6. Those of the candidates who fail to complete the admission formalities within the stipulated time shall cease their chance of admission in the programme and no request or application whatsoever shall be entertained in this regard. The vacancy thus created shall be offered to the next candidate as per merit.
7. The admission to the programmes is purely on provisional basis and is subject to the verification of the documents / certificates to be submitted by the candidates.
8. Any document / Certificate found false / tempered / forged etc. the selection of the candidate shall be canceled and legal action under rules shall follow.
9. In case of admission on the basis of category-under process certificate in the office of the competent authority shall in no case be considered, the admission of such candidate will be canceled without any notice.
