Admission Procedure

The seats for the programmes are fixed as per the intake capacity for the programmes:

The Selection mechanism qualifying an aspirant for seeking admission to the above programs is as under:-

- 1. Aspirants will have to visit the College website http://www.islamiacollege.edu.in
- 2. Submit on-line Selection form.
- 3. An applicant can choose to apply for more than one programme.
- 4. The aspirants have to fill selection form online and have to upload recent passport size photograph (Max 500 KB) with selection form.
- 5. Applicants are advised to make correct entries in the on-line selection form, further no changes in any fields of selection forms will be allowed after submission of selection forms.
- 6. A non-refundable processing fee of Rs. 200/- (Two hundred only) for each Programme, shall be charged.
- 7. The applicants will have to deposit the requisite processing fee on-line through any of the online mode such as Credit Card, Debit Card etc through College website only.
- 8. Applicants have to deposit hardcopies with the Admission Section of the College alongwith following documents:
 - i. Application form
 - ii. Fee paid receipt.
 - iii. Marks card of Graduation (Photo copy)
 - iv. Marks card of 12th class (Photo copy)
 - v. Marks card of 10th class (Photo copy)
 - vi. Category certificate if any (Photo copy)

Applicants who fail to submit hardcopies of the above mentioned documents in the College admission Section within stipulated time frame will not be considered for selection process.

- 9. After the closure date i.e 18-09-2021 no selection forms shall be accepted.
- 10. The Merit list for the Programmes shall be issued after the issuance of Final Roll Order tentatively on 25/09/2021
- 11. The merit list shall be prepared in the following manner:
 - a. Merit of Entrance Test 2021 conducted by the University of Kashmir.
 - b. In case of clash of merit at entrance test the student with higher Graduation merit will be placed higher in the merit list.
 - c. In case of clash of merit at Entrance Test and Graduation marks the student with higher marks at Class 12th will be placed higher in the merit list.
- 12. Applicants figuring in the selection list will have to complete the admission formalities within 7 working days from the issuance of selection list. Failure to complete the admission formalities will render in forfeiture of the seat for the Programme and the same shall be offered to next applicant as per merit.
- 13. The admission formalities mechanism shall be communicated to the aspirant after the issuance of merit list.

IMPORTANT:

- In case of any information found being false, incomplete, incorrect the selection of the applicant shall be cancelled/terminated without any prior notice.
- In case any applicant faces difficulties in submission of selection form can visit College Admission Section on working days from 10 am to 4 pm strictly following COVID SOP's.
