Admission Notification II

Admission to Four-Year Undergraduate Programs (FYUGP) / Integrated P.G. Programs with multiple-exit options for the Academic Session 2025-2026 for leftover seats in different colleges.

The admission process in Degree colleges of J&K, for the Academic Session 2025-26 for various Four Year Undergraduate Programs (FYUGP) / 5- Year Integrated P.G. Programs (IG) notified vide vide No: DCHE/2025/1152 Dated: 15-06-2025 has been closed on 15-08-2025.

However, in view of vacant seats left in some programs and in view of the many representations received from prospective candidates, admissions are re-opened for leftover seats to all colleges of J&K as detailed below:

Terms and Conditions:

- The College and Program-wise list of vacancies as on date is given in Annexure 'A' and can also be viewed on the Samarth Portal.
- All eligible candidates interested in applying for the leftover seats are required to complete the College Applications on the Samarth Portal <https://jkadmission.samarth.ac.in/> within the stipulated timeline. Candidates are advised to follow the instructions issued by the respective colleges on their college websites before applying. Candidates who have not registered in previous rounds owing to late declaration of result or due to any other issue, can also register during this period and apply for admission to these leftover seats.
- Colleges shall grant admission as per the following criteria:
 - Wherever more than 15% seats of a major subject are vacant as on date, the colleges shall admit students to such major subjects on First-Come-First-Serve basis.
 - Wherever less than 15% seats of a major subject are vacant as on date, the college shall consolidate their vacancy positions and admit students strictly by framing a merit list of fresh applicants including non-selected candidates from previous admission rounds on the basis of 10+2 marks. In addition to the merit list, the college shall also prepare a **wait-list of applicants**. The number of vacant seats, merit/wait-list, admission schedule should be duly published on the college website.
- All admission coordinators shall ensure that the fee link is activated immediately after the verification so that candidates get time to pay fee and the selected candidates shall be given **two days** to complete their payment, failing which the colleges shall cancel their admission and the vacancy shall be filled immediately from the wait-listed candidates.
- Colleges shall ensure that the approved intake of the program should not be exceeded in any case
- Candidates who have already secured admission in any college are not allowed to apply for the leftover seats.**
