Wax sealed tenders on letter heads of the tenderers attached with registration certificate issued by the competent authority and CDR worth Rs.10,000/- (Rupees Ten Thousand only) pledged to the Accounts Officer, Islamia College of Science & Commerce, Srinagar must reach the office of the undersigned by or before 11th of November, 2020 upto 3:00 p.m. Rates quoted must be inclusive of all taxes, GST and loading /unloading FOR College stores. The weighment of hard coke and rejection wood to be supplied by the successful tenderer shall be made under the supervision of the College Purchase Committee at registered Dharam Kanta. Intending tenderers must quote their rates for below mentioned quantities and must attach the sample(s) of hard-coke with their tenders:

TENDER NOTICE

FOR SUPPLY OF HARD COKE AND REJECTION WOOD

TERMS AND CONDITIONS:

1. Supply of **Hard Coke A-Grade, dry handpicked and moisture free, Rejection Wood dry and chopped** not found according to the sample/specification's will be rejected and will have to be lifted back by the supplier at his own cost, risk and responsibility. In case the supply on its verification by the officers nominated by this office for the purpose is not found in accordance with the sample or found to be having moisture, dust etc. the same may either be rejected or accepted at the reduced cost as recommended by the Supervising Officer(s).
2. The weight of **Hard Coke A-Grade, dry handpicked and moisture free, Rejection Wood dry and chopped** shall be made at the Govt. approved Dharam Kanta under the supervision **of a Committee and supplier will have to bear charges on account of weighment himself.**
3. In the event of supplier failing, declining, neglecting, delaying supply or in the event of any damage occurring or being caused by the supplier or in the event of any default or failure of the supplier in complying with any of the terms and conditions of the supply order, the Institution with or without any prejudice to any other remedy available to it under law in force in the state shall:
 - a. Terminate the order and / or recover the amount of loss caused due to damage, failure or default as may be determined by the College administration; and or
 - b. Impose a penalty not exceeding 10% of the total value of the contract as the College Administration may determine.
4. The supplier will have to make supply of required quantity of **Hard Coke A-Grade, dry handpicked and moisture free, Rejection Wood dry and chopped within the period as mentioned/specified in the supply order.** If the supply is not received within the stipulated period/time, penalty upto 02% of the cost of the bill for each day of delay will be imposed at the discretion of the Principal, Islamia College of Science and Commerce, Srinagar. In the event of non-supply within the stipulated period, alternative arrangement will be made at the risk, cost and responsibility of the supplier besides forfeiture of the C.D.R. in this regard.
5. The rates quoted are FOR College and inclusive of all taxes, GST, loading, unloading, weighment etc.
6. The rates quoted are valid for a period of one year from the date of issue of this order.
7. The supplier shall have to execute an agreement with the College duly stamped drawn on judicial paper worth Rs. 20/- before execution of the supply to the effect that all the terms and conditions mentioned in as laid down in supply order are accepted by him.
8. 10% of the payment shall be withheld as security-deposit from each running bill of the supplier which shall be released only after successful completion of the contract.
9. The payment will be made for the quantity certified by the officers nominated for the verification of quantity and weighment of **Hard Coke A-Grade, dry handpicked and moisture free, Rejection Wood dry and chopped** which has been disallowed /deducted by the said Committee on account of underweight, dust etc.
10. The GST enabled bill of cost must be submitted in triplicate attached with the latest VAT clearance certificate from the concerned quarters and the payment shall be released subject to issuance of certificate from Sub-committee concerned duly countersigned by the Principal to the effect that the supply has been executed as per specification, terms and conditions laid down in the supply order.
11. The supply of successful tenderer/supplier will be liable to the entire satisfaction of the officers nominated for the purpose and deduction of income tax (TDS) as per Income Tax Act/Rules.
12. The Principal of the College reserves the right to reject or cancel any part or whole supply order without assigning any reason thereof.
13. Any other condition(s) which the College administration imposes shall be final and binding upon the supplier.
14. Disputes, if any, shall be subject to jurisdiction of Courts in Srinagar only.
