The procedure for completion of the admission by selected candidates will be as follows:

1. Visit College website www.islamiacollege.edu.in and navigate to submit MBA Admission Form 2021.
2. Enter the Selection Form No. against which the candidate is selected and submit the online admission form and make payment of prescribed Programme fee online using internet payment methods such as Credit Card/Debit Card/ Net- Banking etc. through college website only. Make Sure to preserve the transaction receipts which may be asked for a student by the college administration. Hard copies of the online submitted forms should be submitted in the Admission Section of the College by or before **22nd of October, 2021**.
3. The admission will be provisional and subject to the production of following testimonials/ documents along with the downloaded and printed **Hard Copy** of the Admission Form.
 - Date of birth Certificate
 - Character and provisional certificate from the institution last attended (in original only)
 - Marks card of Graduation
 - CMAT Score Card
 - Category Certificate issued by competent authority (If applicable)
 - Migration Certificate (If applicable)
 - 2 passport sized photographs.
 - The candidates need to deposit the above-mentioned testimonials/ certificates in original and two attested photocopies of each testimonial/ certificate.
4. The window of admission for merit list No. 07 will remain open from **21st October, 2021 to 22nd October, 2021**.
5. Those of the candidates who fail or miss to complete the admission formalities within the stipulated time shall cease their chance of admission in the Programme and no request or application whatsoever shall be entertained in this regard. The vacancy thus created shall be offered to the next candidate as per merit.
6. The admission to the Programme is purely on provisional basis and is subject to the verification of the documents / certificates to be submitted by the candidates.
7. Any document/ Certificate found false/ tempered / forged etc. the selection of the candidate shall be cancelled and legal action under rules shall follow.
8. In case of admission on the basis of category – under process certificate in the office of the competent authority shall in no case be considered, the admission of such candidates will be cancelled without any notice.
