Sealed tenders on letter heads of the tenderers attached with CDR worth Rs. 10,000/- (Rupees Ten Thousand only) for Hard Coke and Rejection wood and Rs. 5000/- for Iron Stoves along with Accessories in separate envelopes pledged to the Accounts Officer, Islamia College of Science & Commerce, Srinagar must reach the office of the undersigned by or before **09th of November, 2021 upto 3:00 p.m.** Rates quoted must be inclusive of all taxes, levies, GST, loading /unloading and FOR College stores. The weightment of hard coke and rejection wood shall be made under the supervision of the College Purchase Committee at registered Dharam Kanta. Intending tenderers must quote their rates as per below format and attach the sample(s) of hard-coke with their tenders.

**TERMS AND CONDITIONS FOR SUPPLY OF HARDCOKE, REJECTION WOOD AND
IRON STOVES TO BE READ WITH NIT NO. No.ICS/1725-27/F-2 Dated: - 23-10-
2021**

1. Supply of **Hard Coke** A-Grade, dry handpicked and moisture free, **Rejection wood** dry and chopped and **Iron Stoves** along-with accessories not found according to the sample/specifications will be rejected and will have to be lifted back by the supplier at his own risk and cost. In case the supply on its verification by the officers nominated by this Office for the purpose is not found in accordance with the sample or found to be having moisture, dust etc. the same shall be rejected outrightly.
2. The weight of hard coke (A-Grade, dry handpicked and moisture free), Rejection Wood dry and chopped shall be made at the Govt. approved Dharam Kanta under the supervision of a Committee and the supplier shall bear charges on account of weighment himself;
3. In the event of supplier failing, declining, neglecting, delaying supply wholly or a part thereof or in the event of any damage occurring or being caused by the supplier or in the event of any default or failure of the supplier in complying with any of the terms and conditions of the supply order, the Institution with or without any prejudice to any other remedy available to it under law in force in the UT shall:
 - a. Terminate the order and / or recover the amount of loss caused due to damage, failure or default as may be determined by the Institute; and or
 - b. Impose a penalty not exceeding 10% of the total value of the contract as the Institution may determine.
4. The supplier will have to make supply of required quantity of hard coke (A-Grade dry handpicked and moisture free), Rejection wood dry and chopped and **Iron Stoves** along-with accessories ordered for, **within stipulated time as from the date of issue of supply order**. If the supply is not received within the stipulated period/time, penalty upto 02% of the cost of the bill for contract for each day of delay will be imposed at the discretion of the Principal, Islamia College of Science and Commerce, Srinagar. Besides an alternative arrangement will be made at the risk and cost of the supplier.
5. The rates quoted are FOR College and inclusive of all taxes, GST, loading, unloading, weighment charges etc.
6. The rates quoted are valid for a period of one year from the date of issue of this order.
7. The supplier shall have to execute an agreement with the College duly stamped drawn on judicial paper worth Rs. 20/- before execution of the Contract to the effect that all the terms and conditions mentioned in the supply order are accepted by him.
8. 10% of the payment shall be withheld as security-deposit from each running bill of the supplier which shall be released only after successful completion of the contract.
9. The payment will only be made for the quantity, certified by the officers nominated as aforesaid for the verification of quantity and weighment of hard coke.
10. The GST enabled bill of cost must be submitted in duplicate attached and the payment shall be released to the effect that the supply has been executed as per specification and the terms and conditions laid down in the supply order.
11. The undersigned reserves the right to reject or cancel any part or whole supply order without assigning any reason thereof.
12. Any other condition(s) which the undersigned shall impose shall be final and binding upon the supplier.
13. Disputes, if any, shall be subject to jurisdiction of Courts in Srinagar only.

Principal
