Admission to MBA Programme session 2021 Under Self Finance Category (Payment Seat Quota)

Pursuant to closure of admission under Open and Reserved Categories to MBA Course (full time). session 2021 **vide Notification No.ICS/377/89/I-19/A-46/A-7/A-35 Dated 14-06-2021.** It is hereby notified for the information of all those candidates who have applied for admission to MBA Programme but have not been selected under open or Reserved Categories and have given consent for admission under Self Finance Category (Payment Quota) in this College, that there are two vacant seats available under Self Finance Category (Payment Quota). Interested Candidates/Applicants who are desirous to seek Admission under the Self Finance Category (Payment quota) are directed to report to the Admission Section of the College from **(09-11-2021 to 11-11-2021 upto 3:pm)** for Admission to the MBA programme under the Self Finance Category.

The Eligibility criteria for admission to MBA Programme 2021, against the vacant seats **(02 only)** under self-finance quota (Payment quota) are as under: -

- The admission will be granted to those students only who have already given consent in their application Form for Admission to MBA Programme under self-finance Category for the said programme **vide notification No: ICS/377/89/I-19/A-46/A-7/A-35 Dated 14-06-2021.**
- The selection under the payment category will be purely based on the merit of CMAT score as per the procedure specified **vide notification No:ICS/377/89/I-19/A-46/A-7/A-35 Dated 14-06-2021.**
- The candidates who fail to report within the stipulated time period shall not be considered for admission and thereby will forfeit their right of claiming admission for the said programme.
- The selected candidates shall have to complete all the requisite formalities for admission within the time line **(upto 11-11-2021)**. Therefore, the candidates who have already given the consent and have applied under self-finance category are informed to come along with their requisite certificates and the following documents.
 - Date of Birth Certificate.
 - Provisional and Character certificate from the institute last attended.
 - Marks Card of Graduation.
 - CMAT Score Card.
 - Category Certificate issued by competent authority (if application).
 - Migration Certificate. (if applicable).
 - 2 passport sized photographs.

The admission to the programme shall be provisional subject to verification of submitted certificates and documents.
