Final merit lists for various programmes shall be issued 21st of June, 2022 onwards.

They can go through our admission notice available on college website and apply online for number of Programs as per their priority of interest in major discipline defining the Programs.

To make your priorities in terms of offerings from us, we are giving a brief of all Courses with intake based on selection of Major Discipline. To secure an admission applicant must give more than one choice from the list while submitting online application form.

Salient Features:

1. Selection of Minor has to be in aid of Major Subject and will be allotted at the time of counselling.
2. During FYUGP, Switching of Major is possible for a percentage of intake as per NEP Guidelines.
3. Discontinuation of education at a yearly stage will not go waste but will be recognized in terms of a Certificate/ Diploma or a Degree under NEP Guidelines.
4. After discontinuation a learner can restart the academic journey by a re-entry at a yearly stage upto three years period.
5. A learner will be exposed to Multidisciplinary Education to gauge his/her interest and inclination and to increase the knowledge level.
