## ADMISSION AWARENESS NOTICE

### Admissions to Four-Year Undergraduate Programs (FYUGP) / Integrated P.G. Programs - Academic Session 2026-2027

The Department of Higher Education, Government of Jammu & Kashmir, informs all aspiring students that the admission process for the Academic Session 2026-27 for Four-Year Undergraduate Programs (FYUGP) / Integrated P.G. Programs with multiple-exit options across all Government Degree Colleges of J&K shall commence shortly.

This information is being issued in advance to enable students and parents to prepare for the upcoming admission cycle. Students are advised to note the following important changes and updates for the session 2026-27:

#### I. PROCESS OF ADMISSION FOR ACADEMIC SESSION 2026-27

- **Admissions on the basis of 10+2 Merit:** All undergraduate admissions for the session 2026-27 across all Government Degree Colleges in J&K shall be granted on Non-CUET basis as per 10+2 scores/merit.
- **Centralised Admission Portal:** All students shall be required to register and apply through a Centralised Admission Portal. The portal link and registration details shall be notified separately.
- **Preference-based College and Course Allotment:** Students shall be required to submit their course and college preferences on the Centralised Admission Portal. The allotment of colleges shall be made on the basis of 10+2 merit and the preferences submitted by the candidates.

#### II. ADMISSION TIMELINE

- The detailed schedule with specific dates for registration, preference filling, allotment rounds, fee payment and other activities shall be notified along with the formal Admission Notification.

#### III. ADVISORY FOR STUDENTS AND PARENTS

- Students who have passed or have appeared in the Class 10+2 examination from JK Board of School Education, CBSE, or any recognised Board are advised to begin exploring the various programs offered by Government Degree Colleges in J&K.
- Students and parents are encouraged to visit the college campuses of their choice to learn about the programs being offered, understand the structure of Four-Year Undergraduate Programs (FYUGP) under NEP 2020, and interact with the faculty.

- Admission Counselling and Facilitation Cells have been established and are already active in all Government Degree Colleges across the UT.
